With this, a great emphasis was placed on unique visitors to the Regional Partnership's website and national media. Actual results for these focus areas exceeded goals, and work will continue into the future to maintain and grow Northeast Indiana's name on a national level. Additionally, with the Regional Partnership's involvement, 20 new business development projects were achieved in Northeast Indiana. The Regional Partnership met with 68 site selector consultants in 2015, and held meetings with 104 corporate decision makers regarding business development opportunities for Northeast Indiana.
